April memo/minutes

The council called to order the Public Hearing at 6:00 pm. A sign-in sheet was passed around to all in attendance. The Council welcomed Emily Gross Albaugh & Edwin Buswell from KIRPC. A comprehensive plan for the Town of Wheatfield starts with working with KIRPC applying for an OCRA grant. A brief discussion of the procedure needed to be done for this process was discussed. The public hearing was adjourned at 6:24 pm.

The Town Council monthly meeting was called to order at 6:30 pm. The audience was invited to join the council in the Pledge of Allegiance. Roll Call was done with: Brian Kwiatkowski, Dean Stalbaum, Andi Jones, Deborah Norberg(Clerk), Jon Myers(bldg dept)and Marshal Lovas all present. Approval of Minutes for the February 20, 2025 meeting had a motion made to accept from Andi Jones and seconded by Dean Stalbaum. **Passed 3-0**

Andi Jones made a motion to accept the claims presented for the month of March and Dean Stalbaum seconded. **Passed 3-0**

Approval of Payroll for March 31 & April 15 was asked for. Andi Jones made a motion to accept and Dean Stalbaum seconded. Brian K abstained. **Passed 2-0-1**

Report from Cemetery dept the spring cleaning notice gives till May 3 for clean up. Sewer Dept had Dean Stalbaum read the MCO report and stated the WWTP got pumped out twice last month. All running well. No street report and the Building Dept reported 3 fence permits were issued.

Old Business stated bathrooms were being opened, along with Cemetery and Park are being set up and cleaned for warm weather activities. Grass seed will be purchased for replacement grass at the park, cemetery and town hall. Town hall pump will call a plumber to fix the issue of it running rough. Andi Jones made a motion and Dean Stalbaum seconded . **Passed 3-0**

Seems the old white building (that has a new roof from the last council) that used to be used as town hall has been approved to be painted. Andi J. made a motion and Dean S. seconded.

Passed 3-0

New Business stated it was time to clean up properties for spring/summer- Ordinance checking/violation warnings going out following ordinances established by the Town Council. Resolution 2025- for KIRPC was held off till the May meeting. .
